Pumped a preflush of 10 bbls mud clean, 10 bbls dye water ahead of 150 sx (211 cf - 37.57 bbl slurry) Type 3, 2% CaCl2, 0.25#/sx Cello-flake. Displaced w/15 bbls water. Plug down @ 0630 hrs 6/15/02. Circ. 10 bbls cement to surface. WOC. NU BOP, & manifold. PT rams, manifold and casing to 250 psi low and 1500 psi high. Good test.
