Cmt csg w/10 bbl fresh water flush, 180 bbl(500 sx)Halliburton Lite (65/35 cls b/Poz) w/2% CaCl<sub>2</sub>, 1/4# cellophane, 6% gel, 5#/sx gilsonite @ 12.4 ppg w/10.6 gpsx water to yield 2.02 cff/sx, 139 bbl fresh water displacement @ 4 bpm.
