Cross Timbers Operating Co. reached an intermediate hole depth of 2,361' KB on 12/3/00. A string of 7", 20# intermediate casing was set at a depth of 2,343' KB. This string of intermediate casing was cemented with 175 sx (336 cuft) 50/50 poz cement (mixed @ 12.1 ppg) followed by 325 sx (455 cuft) type III cement (mixed @ 14.6 ppg). 1/2 bbl of cement was circ to surface. Drilling resumed the following day.

Cross Timbers reached a TD of 5,035' KB (drillers TD) on 12/10/00 @ 11:00 p.m. A liner string of 4-1/2" casing was set at a depth of 5,034' KB. The top of the liner was located at 2,183' KB. The liner was cemented with 400 sx (580 cuft) of 50/50 poz cement (mixed @ 13.2 ppg). 1/2 bbl of cement was circ off the top of the liner hanger. The Bearcat drilling rig was released on 12/12/00.
