Place ten 6" cement plug at bottom of Dakota, 2050'.
Place ten 6" cement plug at top of Dakota, 1850'.
Place 10' cement plug in surface pipe and install 4" x 6" pipe with proper
inscription and location of well as required. 4" pipe 2' in cement.
Mud in hole 9.6.

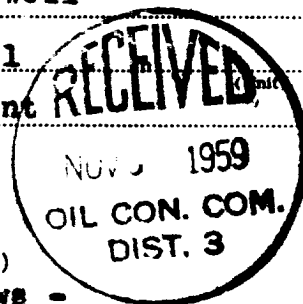
