DETAILS OF WORK

The Pictured Cliffs sandstone is the objective formation which should be found at approximately 2100'. Approximately 110' of 9-5/8" surface casing will be cemented and circulated. A 8-3/4" hole will be drilled to a point just above the Top of the Pictured Cliffs sandstone where the hole will be reduced to 4-3/4", and the well drilled through the sandstone. A schlumberger survey will be run, and if production is indicated 7" or 5-1/2" casing on a packer will be run for a production test.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
