DETAILS OF WORK

 1. Drill surface hole and run wire set approximately 100' 8-5/8" surface casing and cement to surface.
 2. Test surface casing, cement plug and drill to base of Pictured Cliffs sandstone at approximately 2000'.
 3. Run electric log to total depth.
 4. Run and set approximately 1900' of 5 1/2" H-40 14# casing on top of Pictured Cliffs sandstone and cement with 150 sacks of cement.
 5. Move off rotary tools, test production string cement plug, drill cement plug, clean out to bottom and shoot with nitro shot.
 6. Clean out after shot and complete well ready for production.

I understand that this is a preliminary report and that the work is being done by the Geological Survey before operations may be commenced.

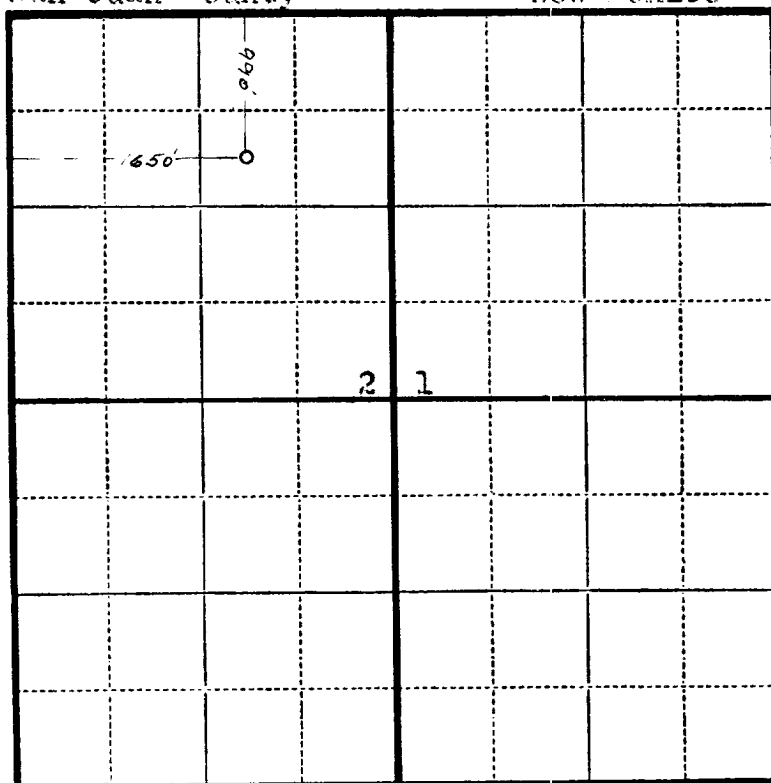
