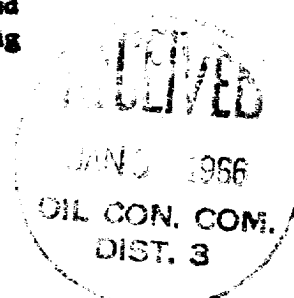

This well was drilled to a T.D. of 1336' in 1926 and completed from Dakota Formation perfs 1328-36' for an IP of 225 BOPD. The well is non-commercial. In May, 1948 the well was temporarily abandoned after an attempt to cut and pull 7" casing. We propose to plug and abandon the well as follows:

5 sack plug at 428' where 5 1/2" casing was cut in 1948.
5 sack plug at surface.
Erect dry hole marker and clean location.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
