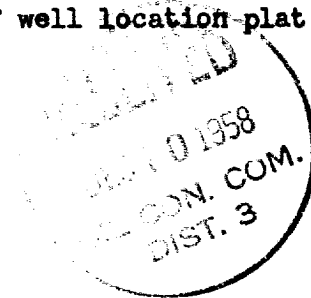

### DETAILS OF WORK

We propose to set 8 5/8" casing at 100' with sufficient cement to circulate, WOC 24 hours, and test casing to 1000' for 30 minutes. We propose to drill a 6 3/4" hole to approximately 1700 feet. This is a "strat" test and will be plugged as directed by U.S.G.S. Attached are copies of well location plat.

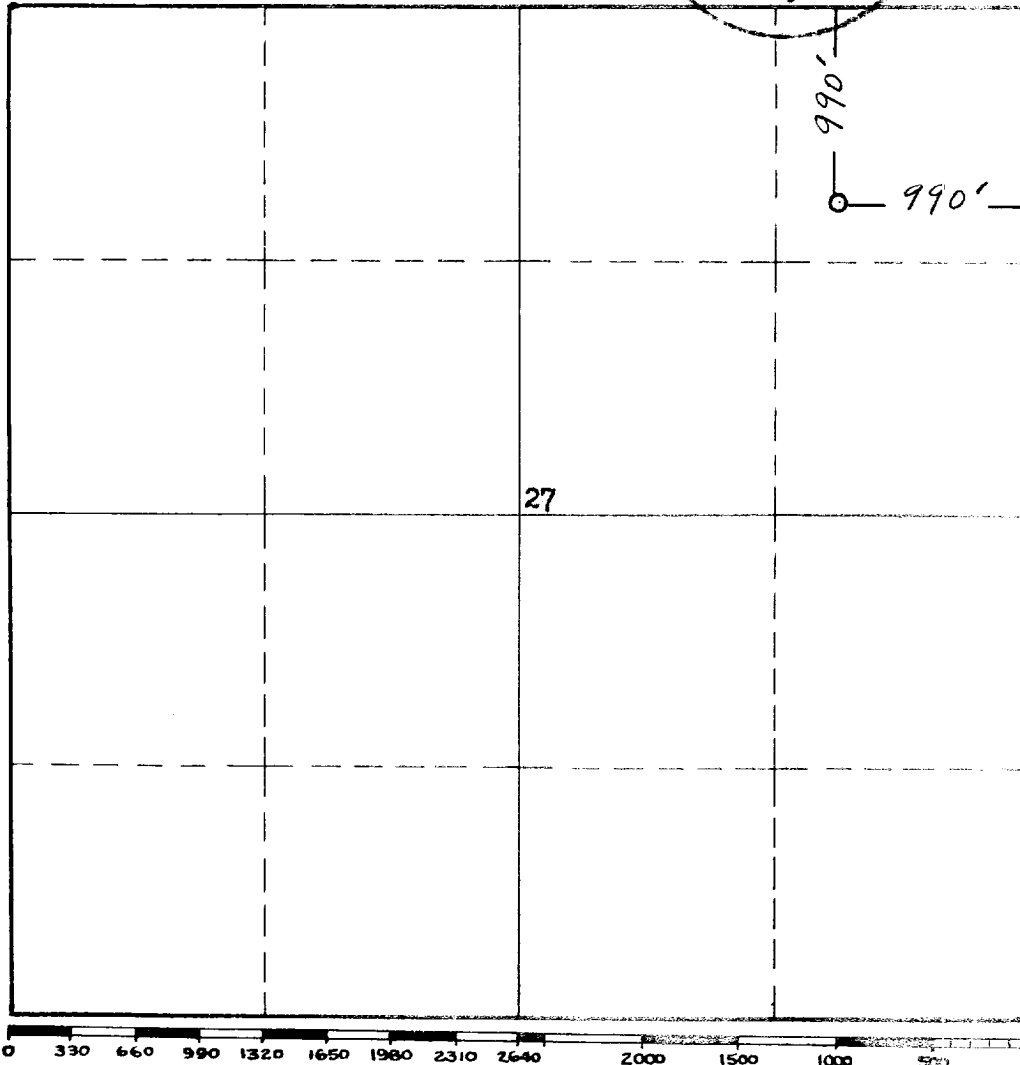
