Due to the non commercial status and the prohibitive cost of reworking, the Summit No. 1 has been plugged and abandoned as follows:

- 1. MI and KU Pulling unit.**
- 2. Pulled 1" tubing.**
- 3. Attempted unsuccessfully to pull 3" tubing.**
- 4. Ran 2" tubing and spotted 50 sacks cement plug over Pictured Cliffs from 1970 to 816'.**
- 5. Tagged top of cement plug w/wireline at 816'.**
- 6. Perforated 3" tubing w/4 shots at 810'.**
- 7. Squeezed Ojo Alamo w/105 sacks cement.**
- 8. Dumped 3 sacks cement in 6-5/8" csg. - 3" tbg. annulus and welded 1/2" steel plate over annulus.**
- 9. Dumped 2 sacks cement in 3" tubing.**
- 10. Welded dry hole marker on 3" tubing.**

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
