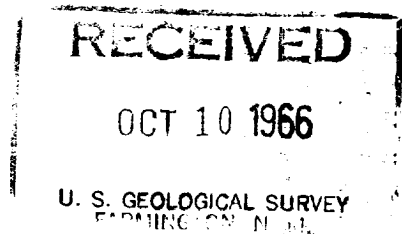

Pull 1" tubing, clean out to TD (1626)
Run 2-7/8" casing and cement to surface, squeezing any holes in the 4-3/4" casing.
Perforate and sand-water free Pictured Cliffs zone.
Run 1" tubing and put well back on production.
