Gentlemen:


We have located two old oil wells within the city limits of Bloomfield that are creating a safety hazard.

1. Bergin #2 F-21-29N-11W
Drilled June 5, 1925. This well is seeping water to the surface and has created a large mudhole near a school.
2. Frank Webber ? C-22-29N-11W
Unknown dates. This well is leaking water to the surface and into the street creating an ice problem in the winter. It is next to a school bus stop.

Copies of bids are attached.

Due to unknown downhole conditions we will be soliciting bids for items such as mud, fishing tools, drill collar rental, mills, water, pipe, cementing services, and trucking as the jobs proceed. Due to the time schedules necessary in this type of operation we will use the criteria of cost and time availability to choose the contractors.


