NMOCD will consider delineation complete for 1RP-4823 and approve of the proposed remediation plan with these stipulations:

- 1. Confirmation bottoms and sidewall samples are required for the area represented by T-1. One sample must be at the border of the area represented by T-2 &T-3.
- 2. Confirmation sidewall samples are required for the area represented by T-2 and T-3. One sidewall sample must be located at the border of the area represented by T-4, where no remediation is required.
- 3. Confirmation sample locations should be no greater than 50 ft. apart.
- 4. On an appropriately scaled map, a) outline the different excavated and lined areas; b) annotate depths of excavation; and c) mark confirmation sidewall and bottom sample locations with GPS coordinates.
- 5. Dated photo documentation of remedial activities.
