Ms. Yu,

Trinity Oilfield Services has been contracted by Cambrian Management to remediate the release referred to in the email thread below (i.e., Grand Banks ARU #14, 5/16/17).

In the thread, there is reference to an incomplete/inadequate initial C-141 being submitted to Tomas Oberding on 5/30/2017, as well as a message from Denise Jones (Cambrian) that a revised C-141 was to be submitted on 7/12/17. There is also a follow-up message from you to Andy Rickard (Cambrian) on 7/26/17 stating that you would be sending him "*...a more recent message with delineation requirements.*" However, I can't find any of this documentation in the NMOCD imaging system, and it appears that a 1RP number was never assigned to the release.

I have attached the original C-141, dated 5/25/17, which was submitted to Mr. Oberding, along with an updated C-141 that includes the approximate square footage of the area affected by the release, include the overspray and the flow path in the adjacent pasture. The exact volume of the release is

unknown, so it is simply listed as being greater than (>) 5 barrels.

If I am mistaken and there HAS been a 1RP # assigned to this release, please forward the number to me for my records. Also, please apprise me of the appropriate NMSLO contact for this site.

As you can see from the photos that I have attached, when I visited the location the ground contamination was not cleaned up. Picture number 4034 shows that there was fresh caliche put on top of the spill and it is soaking back up through it. Picture number 4039 shows that the

release flowed into the previous release area and was not remediated either. I am going to request a full site delineation with a work plan to be submitted once that has been done regardless of amount released due to the size of the spill. The overspray will also need to be delineated.
