Ms. Yu,

We anticipate excavating the respective areas until BTEX and TPH concentrations are below the NMOCD RRALs. Our technician generally pulls samples from the interval which he infers soil is no longer affected above the RRAL and then an additional sample beneath that for confirmation. We anticipated collecting excavation confirmation samples as well; it is our hope we do not have to excavate beyond that respective depths in those two areas but we understand we may have to spot dig in other areas. I hope that this helps! I can discuss over the phone if your prefer. Thanks
