Good morning Mr. Burton:

The approved delineation workplan on September 1, 2017 for 1RP-4773 explicitly states that laboratory analyses for BTEX, TPH extended, and chlorides are required from all confirmation samples locations. On an appropriately scaled map, 1) mark the bottom and sidewall confirmation sample locations with GPS coordinates (or tabulate), and 2) annotate and outline the areas with different depths of excavation.

Please remember to include all associated agencies in communications. NMSLO may have additional stipulations.

A couple of questions regarding the closure report for 1RP-4773:

1. There is a mistake in the liner thickness. Please verify that a 20 mil liner was emplaced, not

a 0.20 mil liner.

2. Were bottom confirmation samples taken for laboratory analyses at the excavated areas represented by SP2, SP3, SP11, SP13, SP16, and SP18 that were not lined? This was a condition specified on the approved delineation report regarding the proposed remedial activities.

Please be advised that this release occurred on State surface. Mark Naranjo will be the correspondent for NMSLO in the interim.
