- Please remember to demarcate the release point on all figures and maps and tabulate the GPS coordinates for the delineation and remediation sample locations.
- Please note that several of the proposed delineation locations are directly over the gas lines.

- All laboratory analyses must have corresponding data from field tests. Provide all field data for depths not submitted for laboratory analyses.
- Photo documentation of the release area and delineation/remediation activities are required.
