Yes, the area to the east of TP-17 and 19 appears to be a reserve pit. The side wall samples collected from the north end (TP-6, TP-13 and TP-38) field screened above the RRAL, however there is a high voltage electrical line and a fence preventing further excavation. We can collect sidewall samples for laboratory analysis from the north end for documentation prior to backfilling.

We are excavating the contaminated soil at the Checkerboard site and are running out of room due to vehicle traffic at the site. The attached drawing shows the area that has been excavated to 4 feet below ground surface (out lined in black dashes). Can we line this area and backfill so we can continue the excavation to the west, southwest and allow vehicle traffic? There is a high voltage power line just to the north of TP-13 and a potential former pit to the west of TP-6. I have included a spreadsheet summarizing the field screening and lab data. I will call you to discuss.
