Ms. Gonzales:

NMOCD approved of the vertical delineation completed thus far for 1RP-5001, and the proposed additional delineation for the area represented by T4 and T5. The proposed remediation plan is approved with these conditions:

1. Bottom confirmation samples, if unlined, for each of the areas with differing proposed depths of excavation.
2. To complete horizontal delineation, sidewall confirmation samples for each area with differing depths of excavation at no greater than 75 ft. apart. At least one sidewall must be at the border between differing depths of excavation.
3. Provide dated photo documentation of remedial activities, including proper emplacement of a liner, and GPS coordinates of the confirmation sample locations.

Like approval from NMSLO required. NMSLO may have additional concerns or stipulations.

Mr. Hohensee: NMOCD sincerely appreciates your timely response to 1RP-5001. Please note that District 1 has an additional Environmental Specialist. Please include Christina Hernandez in all future communications and report submittals.
