Please note that the Ironhouse Draw, which is a NMOSE-identified watercourse, is within 1000 ft. of the release area. The current RRALs are adjusted accordingly to 20.

NMOCD will approve of the preliminary delineation completed for 1RP-4944 and the proposed remediation plan with one condition. Please ensure that all confirmation sidewall and bottom samples are within permissible levels as also required by NMSLO. Provide dated photo documentation and mark confirmation samples locations with GPS coordinates on a scaled map.
