Dear Ms. Haskell:

In the interest of resolution and as depth to groundwater is > 100 ft. bgs, NMOCD will grant closure to 1RP-4843. However, please note that the timeline between release date (Oct. 9, 2017) and first release characterization date (February 6, 2018) suggests that the major release probably infiltrated further down the soil profile than the data indicated. The soil type for this release location- loamy fine sand- has high saturated hydraulic conductivity.

The available information indicates **OPERATOR** has met the requirements of 19.15.29 NMAC and no further corrective action is required. NMOCD considers **1RP-4843** closed. However, this determination by the Oil Conservation Division does not relieve Operator of responsibility should future information indicate a threat to ground water, surface water, human health, or the environment. Furthermore, it does not relieve Operator of responsibility for compliance with any federal, state, or local laws and/or regulations.
