Please address these concerns regarding 1RP-4579.

- Due to the shallow depth to groundwater, NMOCD requests that the area around SP2 be excavated to 4 ft. bgs. (as practicable and attainable, at least 3 ft. bgs.), and then properly set a minimal 20 mil liner. If in agreement, then this 1RP can move towards closure. Otherwise, if the originally proposed 1 ft. bgs is desired, then 1RP-4579 will be deferred.
- For the area around SP1, excavation to 1 ft. bgs is granted.
- Bottom and sidewall confirmation samples using Method 8015 extended (GRO, DRO, MRO) for TPH and Method 300 for chlorides are required.
