Mr. Keyes,

This is a follow up with our meeting this morning to discuss the following site. The following is an Addendum to the ConocoPhillips Lockhart A-35 Battery (1RP-4077) CAP submitted to NMOCD on May 6<sup>th</sup>, 2016.

Page 2, Section: red lettering will be deleted from the paragraph and blue lettering should be added to the paragraph.

Based on the assessment, **CoP proposes the release area within the facility be hand shoveled 4" (four inches) to 6" (six inches). The facility will be addressed at site abandonment.** Based on the assessment, the release around point 3 will be excavated down to 1 ft bgs and the area around point 4 will be excavated down to 2 ft bgs. Representative wall samples will be taken to a commercial laboratory to confirm that all constituents are below regulatory standards. There are buried and surface lines and heater treater and separator running throughout the release. To provide for the safety of people and equipment at the site, the excavation will remain a safe distance away from the buried and surface lines.
