Please address these concerns for 1RP-4596.

1. The provided map suggests that the liner will be emplaced within a 15 ft. radius of the wellhead. Is this true? If not, please redraw and rescale the Google earth image.
2. Discrete sidewall confirmation samples (minimum 4 sample locations) are required of the proposed 4 ft. excavated area using Method 8015 extended (GRO, DRO, and MRO) to complete horizontal delineation.
