Ms. Yu,

The spill for 1RP-5018 occurred inside a bermed facility, and a closure report was submitted for that RP number and will be addressed separately. While Tetra Tech personnel were on site addressing the 1RP-5018 remediation, a non-reportable release occurred along the same spill footprint as 1RP-4759.

A remediation plan/closure report has not been submitted for the 1RP-4759 release as of yet. We began to address the non-reportable release on the same spill footprint, however, in doing so, the impact from 1RP-4759 has also been addressed. Due to the initial release being reportable, confirmation samples were collected every 200 sq ft to ensure proper removal. Once completed, a closure report will be submitted detailing the activities performed for 1RP-4759 and the non-reportable release.
