Jim and Dylan,

As per our conversations, please find attached the *Site Assessment Report and Proposed Remediation Workplan* that has been prepared for ETC's Cotton Draw 10-Inch. As discussed, this project was originally submitted in December, during a time when everyone was still settling in to the new rule. The original contractor only submitted one soil sample from each test trench. I went out again in November with a hand-auger to collect and an additional representative soil sample proximate to the original sample location; the presence of a hard rock layer forced me to submit samples from shallower intervals.

Since then I believe that we are all doing things a little differently. Ideally, we would have delineated to the NMOCD Reclamation Standards as opposed to the NMOCD Closure Criteria beyond 4' bgs. If possible, an approval with the condition that impacts are delineated vertically to the NMOCD/BLM Reclamation Standard during remediation, would save us from having to mobilize a piece of equipment down there and strip out that pipeline an additional time.
