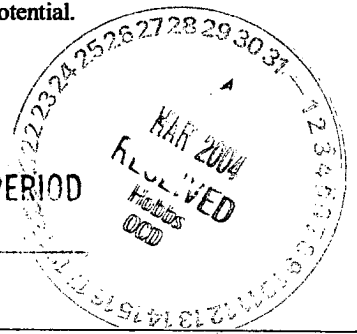

We wish to retain this wellbore for recompletable potential in the Queen, Seven Rivers, and Yates formations. Although ConocoPhillips does not have current plans to recompletable this well, other wells in the area will be tested after this year and will help quantify this potential.
