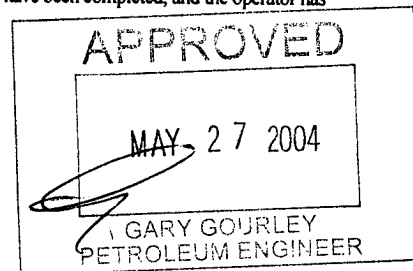

5. Spot 25sx, plug from 2400-2100 (Yates, B-Salt) WOC Tag.
6. Cut 4 1/2" csg at 1100, L/D csg.
7. Spot 85sx, plug from 1150-900 (Stub, 8 5/8 Shoe, T-Salt) WOC Tag.
8. Spgt 40sx, plug from 300-150.
9. 10x Surf, install dry hole marker.
