Describe Cause of Problem and Remedial Action Taken.*

1 BBL oil and 1 BBL produced water was released from the stuffing box due to the seal on the rubber packing blowing out. The rams on the well head were closed to prevent further release. The packing was replaced and the well has been returned to operation.

Describe Area Affected and Cleanup Action Taken.*

1 BBL of oil and 1 BBL produced water was released from the stuffing box on top of the well head due to the seal on the rubber packing blowing out. Due to high winds some of oil and produced water was blown into the pasture. The area affected was on the Northern portion of the Pad next to the pasture with some fine mist reaching approximately 461' feet into the pasture. The total affected area on and off pad was 75' wide by 671' long. Vacuum truck was unable to recover any of the released oil and produced water. Environmental agency will be contacted for remediation.
