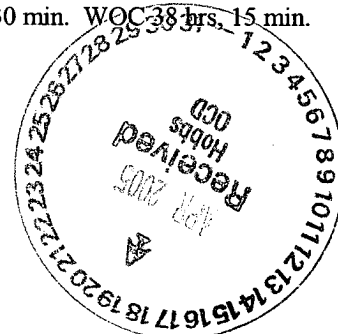

WOC. Tested casing to 1500# for 30 min. WOC 38 hrs. 15 min. Reduced hole to 8-3/4" and resumed drilling.
