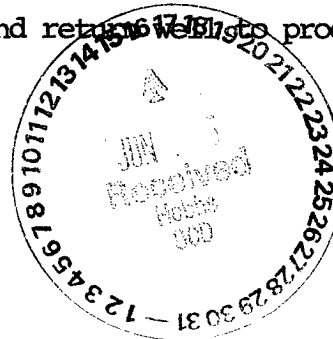
Pull rods. Install BOP. Bull tubing. Clean out frac sand and scale to old TD 6398.

Perf clean Tubb perforations, 6157-6230, with KCl water. Set packer at 6100'± and acidize w. 1000 gal inhibited NE HCl. Swab test.

Unseat packer and remove. Run tubing, rods with pump and return to production.

Work to start on availability of workover rig.
