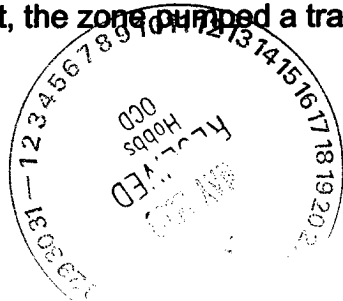

The well was drilled and cased to 4727'. The Queen Sand was perforated from 4446 - 4457 and was non-commercial. A CIBP was set @ 4300'. The Yates was perforated from 3424 - 3428. After a sand frac treatment, the zone pumped a trace of oil and 3 - 4 BSWPD. The well is currently shut-in.
