We will be changing the Intermediate Casing grade from J-55 (36lbs) to a tapered string of J-55 (32lbs) and HCK-55 (32lbs). This casing is of sufficient tensile, compressive, and burst strength to be compliant with the minimum collapse factor of 12.5% overage. Please see the table below for clarification of GMT's intent with this Sundry Notice.
