Devon plans to encapsulate the pit contents and liner capping with 20 mil liner, then cover with 3' of native material capable of supporting native plant growth. We will contour the pit area to prevent erosion and ponding of rainwater.
We will notify the OCD 48 hours prior to beginning work.
