12/29/2005 Rigged up Triple N Services cementer. Pumped 10 sks Class C cement @ 1 BPM @ 400 psi. WOC  
01/03/2006 Drilled out cement. Tested casing to 500 psi, held good for 60 minutes.  
01/04/2006 RIH w/ AD-1 Packer on 2 3/8" tubing. Set packer @ 3618' on 115 jts. Test annulus to 500 psi.  
01/05/2006 Tightened down wellhead and retest annulus. Held pressure.  
01/24/2006 Performed MIT test witnessed by NMOCD. Pressure chart included w/ this sundry.
