- Rat hole and cellar have been filled and leveled. Cathodic protection holes have been properly abandoned.
- A steel marker at least 4" in diameter and at least 4' above ground level has been set in concrete. It shows the

I will be retiring the lines that fed your abandoned RQU #13 well. I will not at this time be able to retire the poles going to the RQU #17 because the same line still feeds the RQU #22 well. However I will retire a portion of that line that feeds the abandoned RQU #19 well because it will have no effect on the RQU #22 well. Per your request I will also be retiring the portion of line and transformers that feed the RQU #33 well.
