04/16/18: MIRU. Tag CIBP @ 6291'. Called Mark Whitaker & was confirmed to continue from that depth. M&P 18 bbls salt gel, followed by 45 sx CI C Neat cmt fr 6291'-5847'. Displaced w/ 33 bbls brine. TOH t/ 5083'. M&P 25 sx CI C Neat cmt from 5083'-4836'. Displaced w/ 27.5 bbls brine.

04/17/18: M&P 21 bbls salt gel, followed by 40 sx CI C Neat cmt from 3905'-3510'. Displaced w/ 20 bbls brine. TOH t/ 3315' & WOC. Tag TOC @ 3520'. Called Mark Whitaker & he informed to skip WOC for next plug, but WOC for following plug. M&P 35 bbls salt gel, followed by 35 sx CI C Neat cmt & spotted from 2634'-2289'. Displaced w/ 13 bbls brine & TOH t/ 1335'. M&P 30 sx CI C Neat cmt from 1335'-1039'. Displaced w/ 6 bbls brine.

04/18/18: Tag TOC @ 1036'. Informed Mark Whitaker of tag depth, who approved going forward. M&P 50 sx CI C Neat cmt from 523' to surface.

04/19/18: Top off well with 1 bbl CI C Neat cmt. RDMO.
