There was African Rue found at this location that was sprayed and removed prior to any reclamation. The extra topsoil was spread on the south, east, and north sides in order to protect the viability and seed. Windrows were constructed on the east side to prevent off-site migration of stabilized soils due to well pad erosion. Berms were constructed on all 4 sides with and compacted. The topsoil was seeded with 1/2 acre of BLM #1 seed.
