05/12/06 - MIRU. Put wellhead & BOP on. RIH w/bailer & tbg (85 jts). Closed well in, shut down.

05/15/06 - Finish running tbg in, tag btm, clean out to TD. POOH w/tbg, RIH w/RBP & tbg to 2,066', set plug. POOH w/tbg, closed well in and shut down.

05/16/06 - RIH w/pkr & tbg, found hole, top @ 732', btm @ 854'. POOH w/tbg, dug out cellar & shut down.

05/17/06 - Cut off 4-1/2 bell nipple, weld on 5-1/2 bell nipple on 4-1/2 csg. Put wellhead on. BJ squeezed well, pumped 250 sxs cmt. RD.

06/06/06 - MIRU. PU collars, RIH, tag @ 524', drill out cmt, fell through @ 812'. Tested well to 300 psi, held good. Shut down.

06/07/06 - Continue in hole, tag, fill clean out. Circulate, clean, POOH, LD collars & swivel. RIH w/tbg, latch onto plug, release, POOH. RIH w/SN & tbg, pump & rods. Hang on. RD.
