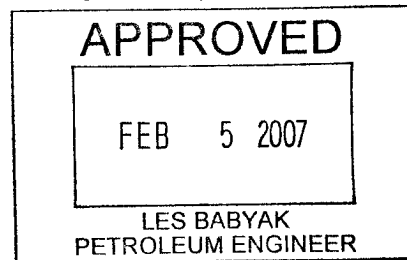
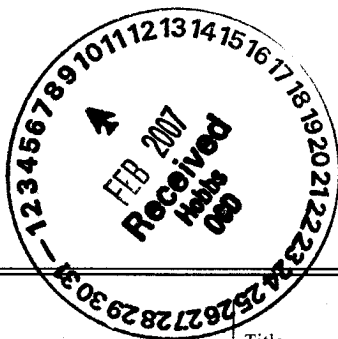

Mewbourne Oil Company received an approved APD on 11/20/06 for the above captioned well. After further review, MOC would like to eliminate the 13 3/8" casing string. This string will be replaced with 8 5/8" 32# J55 and set at 1000' (50' into the Rustler). MOC would also like to change the TD from 9400' to 8600' in the Bone Spring and set 4 1/2" or 5 1/2" casing (to be determined after logs). After further review, MOC will function test BOPE and pressure test BOP and 8 5/8" 32# J55 surface casing to 1500# with rig pump instead of 3rd party testers as per Les Babyack w/Carlsad BLM.
