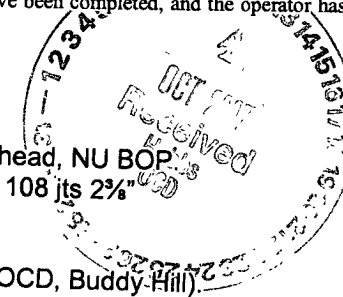

Contacted NMOCD, Buddy Hill. MIRU Triple N rig #22 & plugging equipment. ND wellhead, NU BOPs. Released loc-set packer and POOH w/ 108 jts tubing. RIH w/ 5 1/2" HM tbg-set CIBP on 108 jts 2 3/8" production tubing. SDFN.

09/28/07

Contacted NMOCD, Buddy Hill. RU cementer and set 5 1/2" CIBP @ 3,420' (ok'd by NMOCD, Buddy Hill). Circulated w/ mud and SI BOP, pressure-tested 5 1/2" casing @ 500 psi 15 minutes, held w/ no loss. Pumped 25 sx C cmt 3,420 - 3,174'. PUH w/ tubing to 2,945' and pumped 25 sx C cmt 2,945 - 2,699'. PUH w/ tubing to 1,266' and pumped 25 sx C cmt 1,266 - 1,020'. PUH w/ tubing to 601' and pumped 25 sx C cmt w/ 2% CaCl₂ @ 601'. POOH w/ tubing and WOC 3 hrs. RIH w/ tubing and tagged cmt @ 400'. PUH w/ tubing to 253' and circulated 35 sx C cmt 253' to surface. POOH w/ tubing, topped off 5 1/2" w/ cmt. RDMO.
