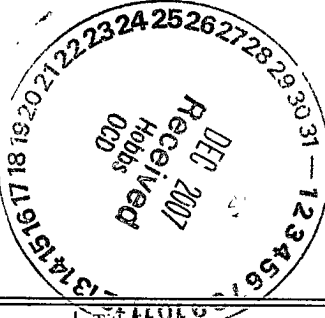

- 3) ATTEMPT TO PERF. & SQZ. A 130 SX. CMT. PLUG @ 325'-3'.
- 4) DIG OUT & CUT OFF WELLHEAD 3' B.G.L.; WELD STEEL PLATE ON CASING & INSTALL DRY HOLE MARKER.

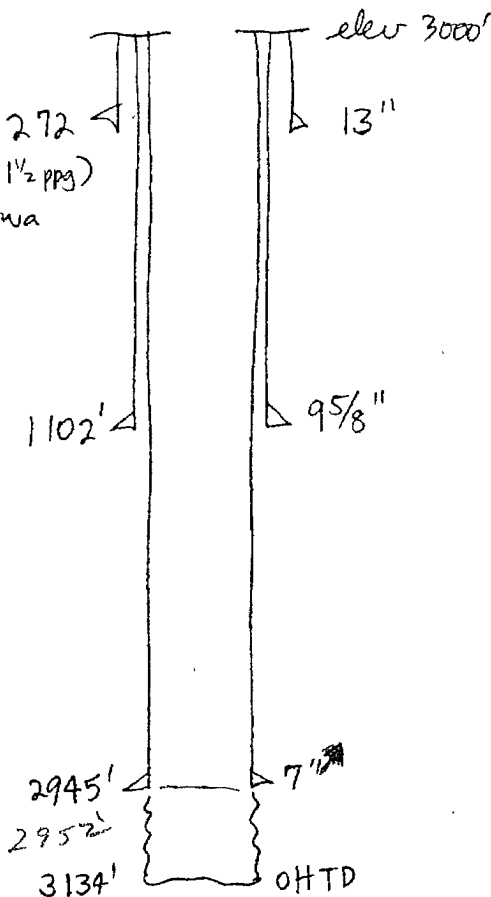
