Set composite plug @ 6150'+/- and perforate the Lower Blinebry from 6010-30', 6040-50' @ 2 spf, then perform acid ballout and fracture treat.

Set composite plug @ 5900'+/- and perforate the Upper Blinebry from 5790-5805', 5820-50', 5858-85' @ 2 spf, then perform acid ballout and fracture treat.
