2nd stage: 20 bfw, 1200 sx HLC with 6# salt, 1/8# Poly-E-Flake (s.w. 12.6 ppg, yield 2.01 ft3/sx) plus 300 sx Class "C" with 1% CaCl2 (s.w. 14.8 ppg, yield 1.32 ft3/sx). Plug down at 12:30 pm CDT 9-4-08. Circulated 154 sx excess cement. WOC time 43 1/2 hrs.

Centralized middle of shoe joint, top of 4th joint, 7th joint, 10th joint and above and below the DV tool.
