1st stage: 20 bfw, 600 sx HLC with 6# salt, 3# Pheno-Seal (s.w. 12.6 ppg, yield 2.01 ft³/sx) plus 350 sx Class "C" with (s.w. 14.8 ppg, yield 1.32 ft³/sx).

2nd stage: 20 bfw, 1350 sx HLC with 6# salt, 1/8# Poly-E-Flake (s.w. 12.6 ppg, yield 2.01 ft³/sx) plus 300 sx Class "C" with 1% CaCl₂ (s.w. 14.8 ppg, yield 1.32 ft³/sx).

Circulate to surface.

If first stage does not circulate, contact BLM prior to pumping second stage.
