3. RIH w/ tbg, tagged cement @ 503', pump 12 bbl 9.5 ppg salt gel down tbg. POH w/ 5 jts tbg, end of tbg @ 360', pump 64 sk 14.8 ppg cement down tbg. POH w/ tbg, top off 7" csg w/ 4 sk cement. Top plug witnessed by Paul Flowers, top off witnessed by Pat McKelvey. 4/20/09

4. Cut off csg 4' below ground, cement at sfc in 7" csg & annulus. Witnessed by Paul Flowers. 4/21/09
