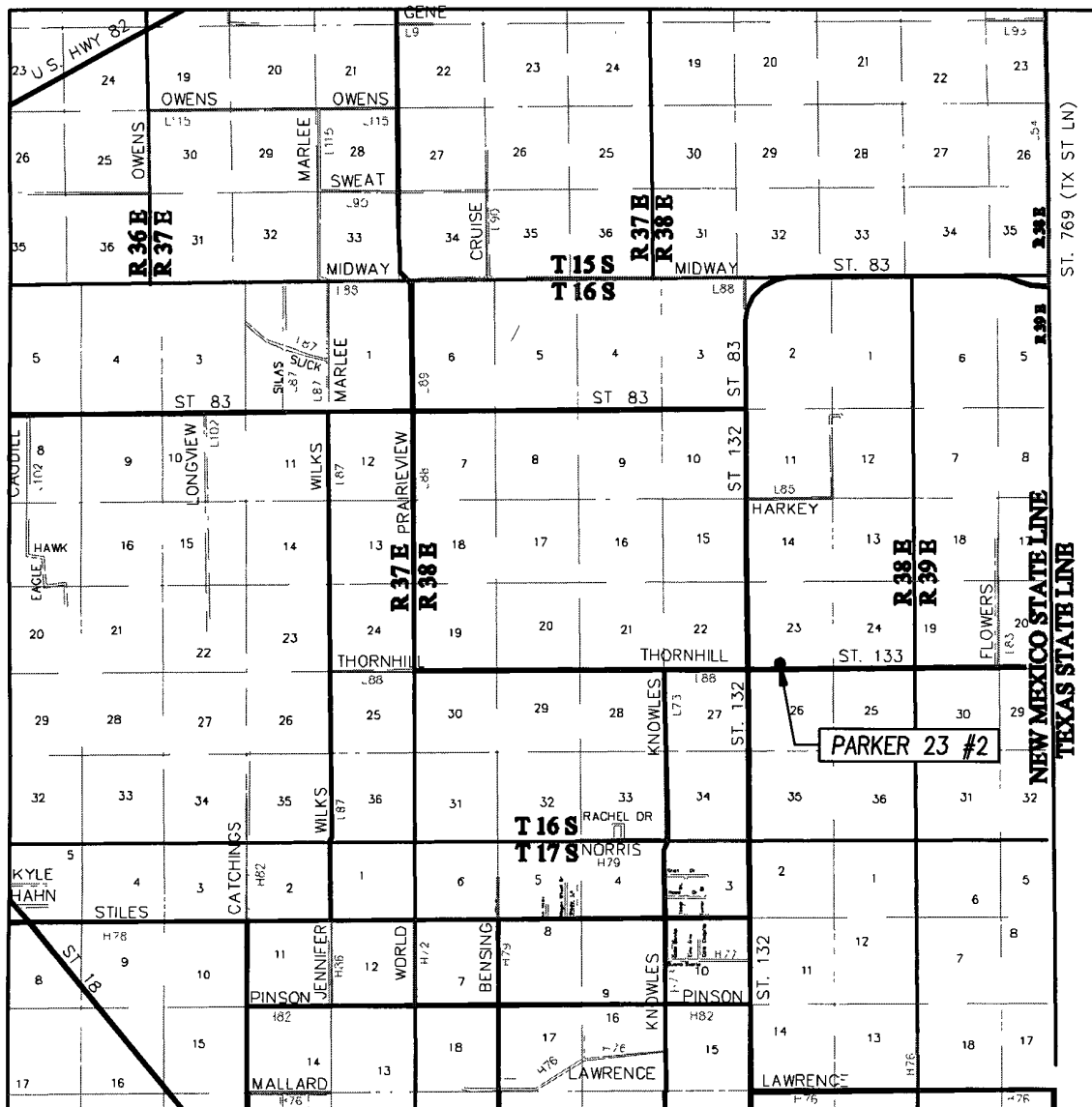

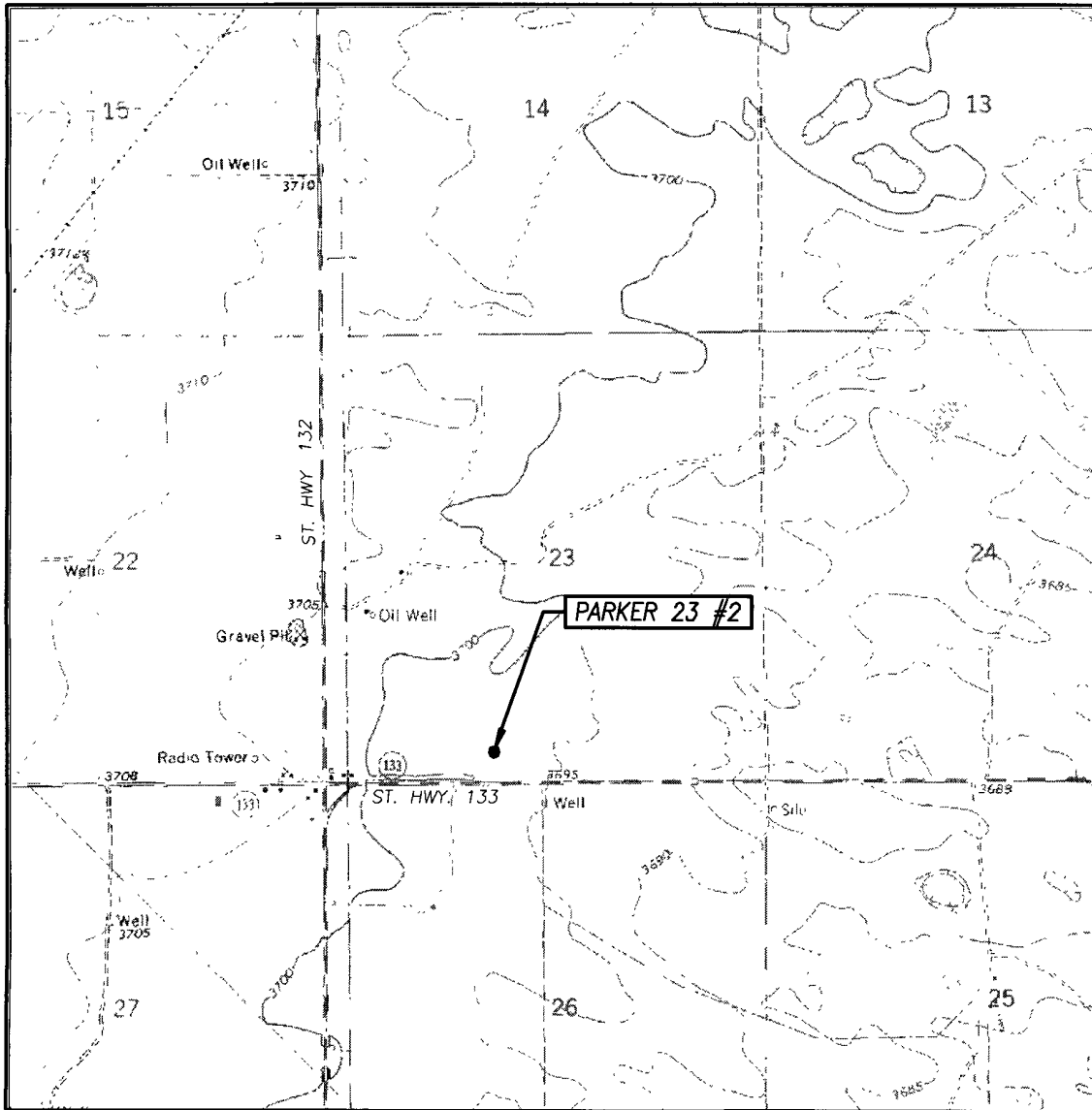

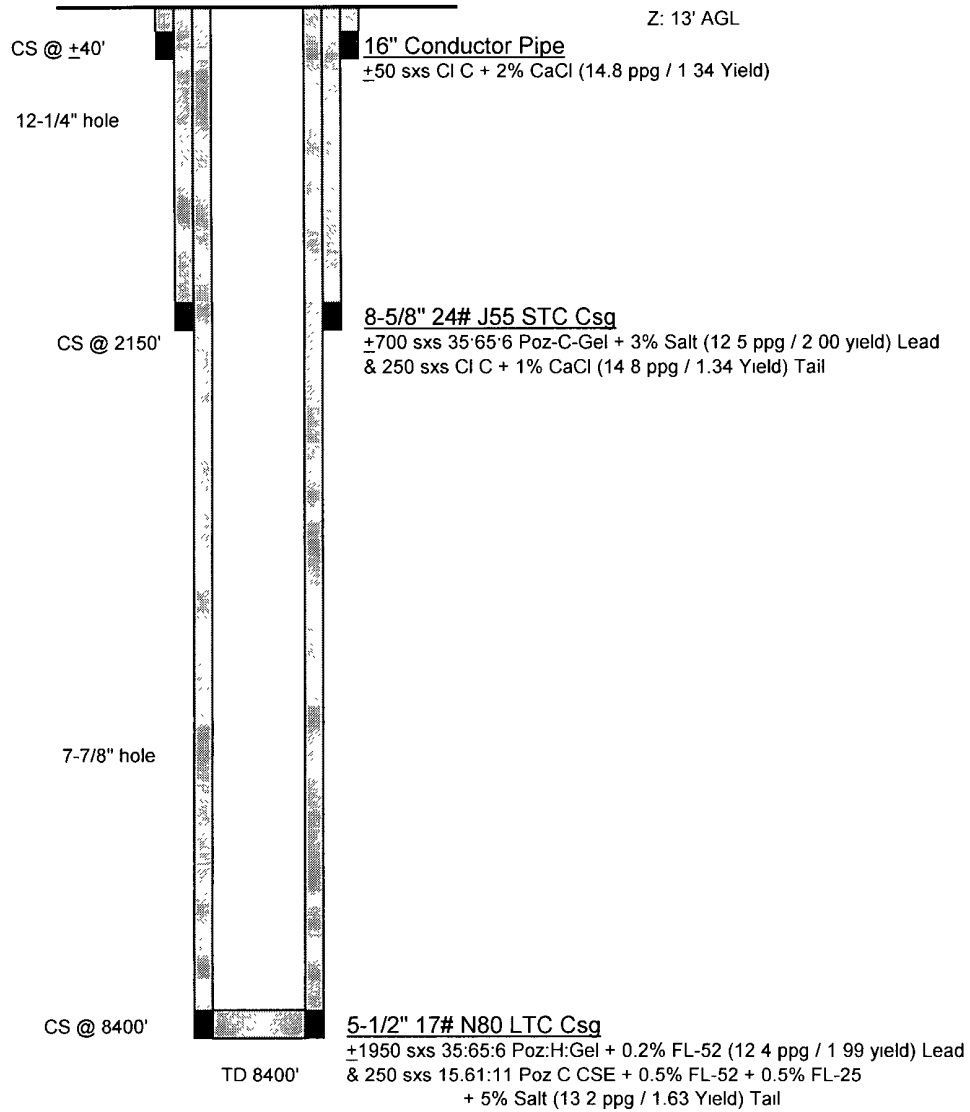




Parker 23 #2
