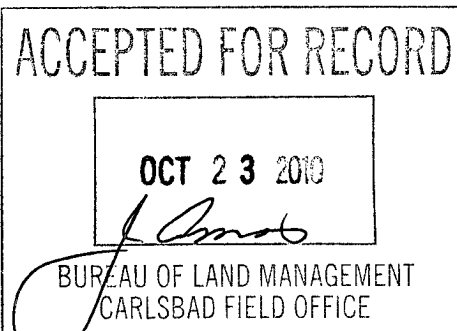

1. Remove flowline, deadman, and any other debris from location
2. Remove caliche and contaminated soil from location and disposed at an approved Conoco Disposal
3. Replace with 1'-3' caliche for barrier
4. Top location with 1'-2' topsoil as needed
5. Level and contour to surrounding area
6. Build an earthen berm at access to prevent vehicular traffic
7. Rip and seed all disturbed areas with BLM # 2 seed mixture using an approved seeder
