

Installed BOP. Drilled out cement plug surface to 20'. Ran 2" tubing to 4000'. Halliburton spotted 30 sx regular cement 4000' to 3865'. Pulled tubing, removed BOP & cut off 7" nipple. Halliburton spotted 20 sx cement surface to 90'. Installed regulation monument. Mud laden fluid between plugs. Plugged and abandoned @ 1:00 PM 8/24/62.
