Federal "G" #1 SWD was back flowed to the Federal "D" battery (Fed. "D" #1 was shut in for repairs) to reduce tubing pressure and the well began flowing oil on January 7, 1991. Attached is a letter of explanation sent to the B.L.M. on August 8, 1991.

Two batteries for the Federal "G" lease were set on the Federal "D" lease - SE 1/4 SE 1/4 of Sec. 31, Twp. 9S, Rge. 36E, Lea County, New Mexico. The subject well flows down a two inch flowline to the Federal "G" battery.

A request for "Off-Lease Storage and/or Measurement" has been submitted to the State of New Mexico in Santa Fe and to the B.L.M. in Carlsbad.
