All records previously filed reflect an elevation of 3981 no reference point, total depth of 4982 and 4 1/2" casing set at 4982. Files now available indicate that correct data from Kelly Bushing is elevation 3991, total depth 4977 with 4 1/2" casing set at 4977. Perforations reported at 4918 to 4960 are correct at KB datum.

It is now proposed to deepen to 5000' and treat open hole 4977-5000 with 500 gal mud acid. Return to production from perfs and open hole.
